

**LOWER OXFORD TOWNSHIP  
CHESTER COUNTY, PENNSYLVANIA**

**RESOLUTION No. 2018 -14**

AND NOW THIS 9<sup>th</sup> day of July, 2018 be it and it is hereby resolved by the Board of Supervisors of Lower Oxford Township, Chester County, Pennsylvania as follows:

WHEREAS Landhope Oxford I, LLC, a Pennsylvania limited liability company has secured final land development and subdivision approval by Resolution No 2018-13 dated June 11, 2018 and;

WHEREAS said land development plan includes within it certain improvements to Conner Road, a township road with its intersection with Pennsylvania Route 10; and

WHEREAS such construction and improvements require the closing of that portion of Conner Road during the period of construction; and

WHEREAS the Board of Supervisors of Lower Oxford Township has the authority under the Second Class Township Code to order the closing of roads;


NOW THEREFORE, based upon the above factors the Board of Supervisors of Lower Oxford Township resolves at follows:

1. Conner Road from its intersection with Pennsylvania Route 10 shall be closed beginning July 9, 2018 from that intersection to the point at which Conner Road intersects with Reedville Road, a Lower Oxford Township Road;
2. Conner Road from Reedville Road to the area of construction on Conner Road will be opened for local traffic;
3. As a part of this closure for construction purposes the township hereby establishes the following detour routes caused by the closure of Conner Road;

- a. Traveling North on Pennsylvania Route 10, travelers are directed to continue North on Route 10 past Conner Road to a right turn onto Township Road. A detour signed is placed at the intersection of Route 10 and Conner Road;
  - b. For those traveling South on Pennsylvania Route 10, a notice of the detour and detour directions shall be placed at the intersection of Pennsylvania Route 10 and Cheek Road with the consent of the Board of Supervisors of Upper Oxford Township, to turn left on Township Road;
  - c. Signs shall be placed at the intersection of Township Road and Conner Road showing that the road is closed and no through traffic but that local traffic is permitted;
  - d. A sign shall be placed at the intersection of Reedville Road and Conner Road notifying travelers that Conner Road is closed at the other end but that local traffic is permitted.
  - e. Such other detour notifications as may be necessary as work continues.
4. Lower Oxford Township Board of Supervisors hereby notifies the public that it has by written correspondence notified emergency management personnel and organizations, school bus companies and Union Fire Company of the road closure.




